Our land at Learmonth is sold, settlement was the 26th May, the money is in our bank account. We did very well out of Learmonth. We purchased it for \$9,000 our next door neighbour the farmer used it and paid rent which covered the rates we sold it for well over \$300,000.

The Learmonth Sub Committee recently met and is now in the process of putting a presentation together for a Special General Meeting. Three options will be proposed. 1st option, is to invest the money and use the income to support future combine and divisional rallies, 2nd option, is to purchase a small factory, use it for storage of our equipment and records, rent the office space to cover the out goings. 3rd option is to purchase a rural property to be used for the storage of our equipment, records, a meeting place and use it as a low cost camp ground. Use the camp fees to cover the outgoing costs.

Our key objective is to ensure the use of the funds provides a long term benefit to our members and does not become a financial burden to us. CAMERONS BIGHT POLICY STATEMENT

For over 80 years this Club has, as its primary function, the provision of and the participation in, monthly rallies. However, as part of the operation of the Club for over 60 years we have had (and still enjoy) a continuous participation in what we fondly called "Sorrento" now "Camerons Bight".


But things change. Whilst we have a good ongoing relationship with the Foreshore Management Committee, and have a 3 year occupancy agreement with them, there are certain provisions regarding our site occupancy on which we have mutually agreed, the basic one being the sites we do not occupy are returned to the Foreshore Committee. These sites are then made available for the general public to occupy.

It is in the interests of the Club that we maximise the occupancy of the sites allocated to us in order that we maintain the site allocation we presently enjoy. Non-use of our sites by us will ultimately mean that the Foreshore Committee will have strong grounds to reclaim them in the future.

Therefore an important aim of the Camerons Bight Site Allocation Sub-committee is to maintain occupancy of as many sites as possible for as long as possible.

To this end, your Executive has developed the following Policy Statement, viz:

- To gain Rally credits,
 - (a) All site bookings whether for packages or particular periods, including individual rally weekends, must be booked through the Site Allocation Committee by the due cut-off date.
 - (b) Site bookings must be for the sites able to be occupied for the duration of the booking. - Only sites allocated to the Club as per the MOU may be booked through the Club Allocation system
 - (c) In order to qualify for the Club off-peak discounts, members must have occupied a site and were eligible last season.
- Persons desiring to join the Club during the Sorrento season shall not be eligible for Club site discounts.
- the club will hold various activities over the season and as always anybody in attendance can be involved.
